Sub: Inclusion of "Additional Units" to the electricity bills of Soil Conservator Training Institute, 12th Mile (Consumer Id.: 1000345292).

Sir,

During the random Inspection of HT Consumers under Byrnihat Division on the 12.02.2025, it was found that the R & Y Phase PT Supplies to Billing Meter No. IN4000303 of Soil Conservator Training Institute, 12th Mile (Consumer Id.: 1000345292) were missing due to carbon formation at PT tapping points which were then corrected only on the 20.03.2025 (on the spot correction on the 12.02.2025 could not be done due to unavailability of metering materials at site). From the trend of consumption, it may be estimated that the PT supplies (R & B Phase) might have got missing since the 01.02.2025.

In view of the above and to compensate for the loss of revenue to MePDCL on account of voltage supply missing in R & Y Ph, 3502.78 kVAh of additional units may please be included into the Electricity Bill of this consumer and may be added along with the Bill Cycle of March or April, 2025.
