Sub: Inclusion of "Additional Units" to the electricity bills of Administrative Officer, ICAR, Uiam (Consumer Id.: 1000345348).

Sir/Madam,

During the Reading cum Inspection of HT Consumers on the 15.01.2025 at the LT-CT Metering Unit of Administrative Officer, ICAR, Uiam (Consumer Id.: 1000345348), it was found that B Ph PT supply to Billing Meter No.: IN4000426 was missing due to carbon formation at PT tapping point (corrected). From the MRI details, it has been established that since the 20.06.2024, the magnitude of B Ph Voltage has been found to be "0". Correction of the same was done on 15.01.2025.

In view of the above and to compensate for the loss of revenue to MePDCL on account of voltage supply missing in B Ph, **100650.77 kVAh** of additional units may please be included into the Electricity Bill of this consumer and may be added along with the Bill Cycle of March, 2025.

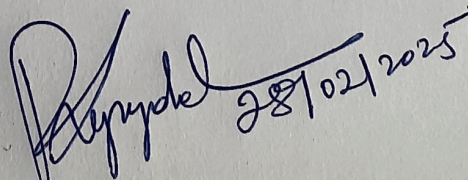

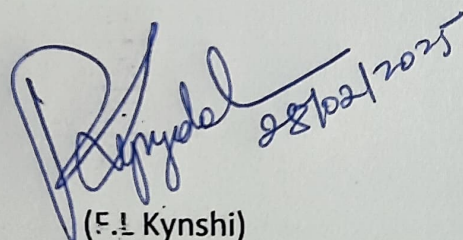
