The office of the undersigned has found the old billing meter (Meter No.: MEB89474) of Vodafone Essar Spacetel Ltd., Umroi (Consumer Id.: 1000198050) totally burnt, replacement of which with new Meter No. MS5000803 was undertaken by this office on the 30-04-2025. However, it has been further observed that for the period w.e.f 17-08-2024 to 28-04-2025, the MR has wrongly billed this consumer on PROV (Door Lock) basis instead of IDF billing basis giving rise to billing the FC component only.

Therefore, to compensate for the loss of energy for the period above, 42,378.00 of Additional Units (kWh) may please be included into the electricity bills of this consumer (Bill Cycle of June, 2025).
