ID: 1000197935), Umroi to be defected (Meter Impulse fails to blink inspite of heavy current (21A) flowing through the conductor). The defected meter above was replaced with 3Ph Whole Current JPM Make Smart Meter No. 22001209 on the 03-07-2025 with initial readings: 00.00KWH, 00.00KVAH. To asses the consumption pattern of this consumer, inspection was again conducted on the 05-08-2025 (after 33 days) and the kWh reading observed was 1268.22 (Video Proof available).

In light of the above, the unit loss of 13296.00 KWH considered for 365 days only (One Year) may please be recovered as Additional Units (kWh).
