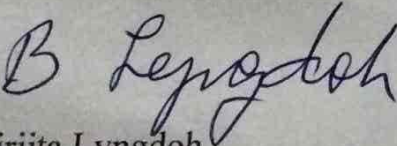
Further more, the meter has been defunct for many months.

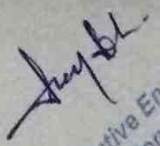

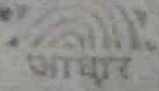
