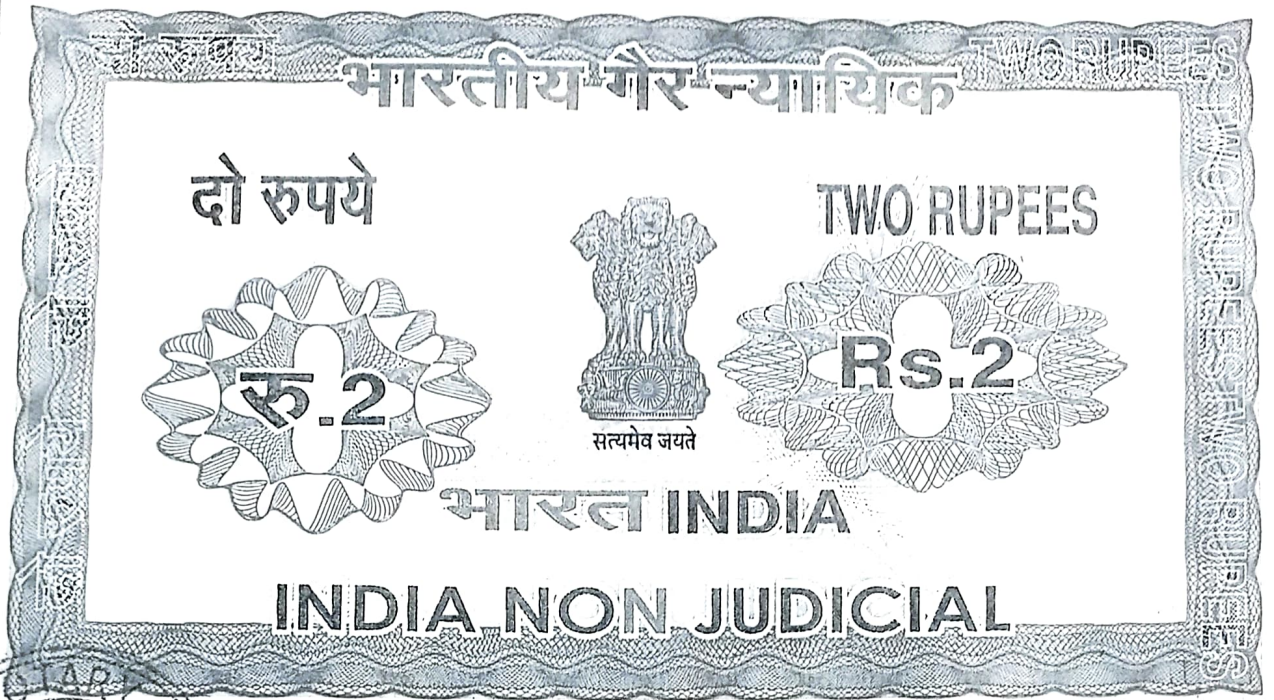

BETWEEN

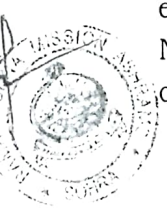
