AN AGREEMENT made this the _____ day of _____ 20____ between
the undersigned **E. Tangsong** and his successors and assigns (hereinafter referred to as the Consumer) of the One Part and the Meghalaya Energy Corporation Ltd. (hereinafter referred to as MeECL) of the Other Part

Note : The term 'consumer' includes an individual person (whether male or female), a body of persons, a company, society, firm, association or organisation

WHEREAS, the consumer has applied to the MeECL for supply of electricity to its premises and the MeECL has agreed to give the supply under the terms and conditions hereinafter appearing

NOW, THEREFORE, the agreement witnesses -

1. That the supply shall be given to the premises located at **Nongitniang** with the consumer as owner/occupier of
2. That the supply shall be for the purpose of **Domestic lines** the load whereof shall not exceed **2kw** watt(s)
3. That the provisions of the Electricity Act, 2003 and the Regulations, Code and Orders including Tariff Orders, as may be made from time to time by the Meghalaya State Electricity Regulatory Commission shall apply and bind the consumer and the MeECL alike
4. That the consumer shall regularly and timely pay to the MeECL all charges and may be due for the supply of electricity
5. That the Agreement shall be a period of two years and may be renewed for a further period. Provided that supply shall not be terminated by mere efflux of time if the consumer is willing that the agreement is renewed
6. That the Agreement shall be terminated if the consumer on its part desires it so and gives to the MeECL a prior notice of not less than one month or, on the part of the MeECL, if the consumer has violated any of the terms and conditions of the agreement

Signature

Provided that on the part of the MeECL, no supply will be given to the consumer for any reason for the proposed termination and supply will be cut off immediately and without statement of any, duly considered longer period of time, and the supply of electricity cut off

7. That the terms and conditions of this Agreement shall be effective from the date supply of electricity is commenced

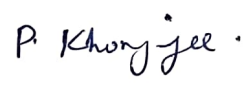
