3. That the provisions of the Electricity Act, 2003 and the Regulations, Code and Orders including Tariff Orders, as may be made from time to time by the Maharashtra State Electricity Regulatory Commission shall apply and bind the consumer and the MSEDCL also.
4. That the consumer shall regularly and timely pay to the MSEDCL all charges and may be due for the supply of electricity.
5. That the Agreement shall be a period of two years and may be renewed for a further period.

6. That the Agreement shall be terminated if the consumer on its part desires, it so and gives to the MSEDCL a prior notice of not less than one month or, on the part of the MSEDCL, if the consumer has violated any of the terms and conditions of the agreement.
