

AGREEMENT FOR SUPPLY OF ELEG LOW TENSION



AN AGREEMENT made this _____ day of _____ 20____

between _____ and his successors and assigns hereinafter referred to as the Consumer of the One Part and the Meghalaya Electricity Corporation Ltd. an electricity distribution licensee under the Electricity Act, 2003 and its successors and assigns (hereinafter referred to as MeECL) of the Other Part

Definition The term "consumer" includes an individual person (whether male or female), a body of persons, a company, society, firm, association or organisation.

WHEREAS, the consumer has applied to the MeECL for supply of electricity to its premises and the MeECL has agreed to give the supply under the terms and conditions hereinafter appearing

NOW, THEREFORE, the agreement witnesses:-

1. That the supply shall be given to the premises located at Barak Road, Jorhat with the consumer as the occupier of _____
2. That the supply shall be for the purpose of Light _____
The load which shall not exceed _____ (Amps) _____ (Watts).
3. That the provisions of the Electricity Act, 2003 and the Regulations, Codes and Orders including Tariff Orders, as may be made from time to time by the Meghalaya State Electricity Regulatory Commission shall apply and bind the consumer and the MeECL also.
4. That the consumer shall regularly and timely pay to the MeECL all charges and may be due for the supply of electricity.
5. That the Agreement shall be a period of two years and may be renewed for a further period. Provided that supply shall not be terminated by mere efflux of time if the consumer is willing that the agreement is renewed.
6. That the Agreement shall be terminated if the consumer on its part desires it so and gives to the MeECL a prior notice of not less than six months or, on the part of the MeECL, if the consumer has violated any of the terms and conditions of the agreement.

Provided that on the part of the MeCCA, notice shall be given to the consumer by way of a notice for the proposed termination and giving him opportunity to state his case and his statement if any duly considered before the agreement is terminated and the supply is permanently cut off.

- That the terms and conditions of this Agreement shall be effective from the date supply of electricity is commenced.

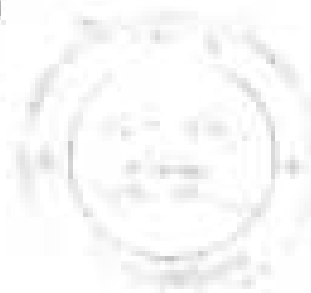

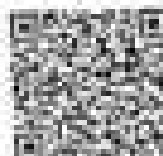
