



AGREEMENT FOR SUPPLY OF ELECTRIC
LOW TENSION

AN AGREEMENT made this the _____ day of _____
between _____ and his successors and assigns
(hereinafter referred to as the Consumer) of the One Part and the Meghalaya State Electricity Board
and electricity distribution licensee under the Electricity Act, 2003 and its successors and assigns
(hereinafter referred to as the Board) of the Other Part.

Inter: The term 'consumer' includes any individual person (whether male or
female), a body of persons, a company, society, firm, association or organization.

WHEREAS, the consumer has applied to the Board for supply of electricity in its premises
and the Board has agreed to give the supply under the terms and conditions hereinafter appearing.

NOW, THEREFORE, the agreement witnesses-

- 1) That the supply shall be given to the premises located at Sahkynkur, with
the consumer as user/occupier of.
- 2) That the supply shall be for the purpose of Domestic use and
amount shall not exceed 2000 watts.
- 3) That the provisions of the Electricity Act, 2003 and the Regulations, Code and Orders, including
Tariff Orders, as may be made from time to time by the Meghalaya State Electricity Regulatory
Commission shall apply and bind the consumer and the Board alike.
- 4) That the consumer shall regularly and timely pay to the Board all charges and may be due for the
supply of electricity.
- 5) That the Agreement shall be for a period of two years and may be renewed for a further period
provided that supply shall not be terminated by mere efflux of time if the consumer is willing
that the agreement is renewed.
- 6) That the Agreement shall be terminated if the consumer on its part decides it to and give to the
Board a prior notice of not less than one month or, on the part of the Board, if the consumer has
violated any of the terms and conditions of the agreement.

Provided that on the part of the Board notice shall be given to the consumer in writing of the proposed termination and giving him opportunity to state his case in writing. This date considered before the agreement is terminated and the supply of electricity is cut off.

That the terms and conditions of this Agreement shall be effective from the date supply of electricity is commenced.


