AGREEMENT FOR SUPPLY OF ELECTRICITY AT LOW TENSION

This is the _____ of 202 _____ between _____ and his _____
(hereinafter referred to as the consumer) of the one part and the Meghalaya Power
Corporation Limited an electricity distribution licensee under the EA, 2003 and its successors and
hereafter referred to as the Distribution/Utility/MePDCL) of the other part.

The term 'consumer' includes an individual person (Whether male or female), a body of persons, a
company, society, firm association or organization.

Whereas, the consumer has applied to the distribution utility for supply of electricity to the premises and the
distribution utility has agreed to give the supply under the terms and conditions hereafter appearing.

And therefore, the agreement witness -

That the supply shall be given to the premises located at Khapmara with the Consumer
owner/occupier of.

That the supply shall be for the purpose of BP the load whereof shall not exceed
1660 Watts.

That the provision of the EA, 2003 and the regulations, code and orders including tariff orders, as may be
from time to time by the MSERC shall apply and bind the consumers and the distribution utility alike.

That the consumer shall regularly and timely pay to MePDCL all charges may be due for the supply of
electricity.

That the consumer shall pay the Transformer Maintenance charge as stipulated by the license and
the maintenance and replacement of the transformer on account of failure shall be the responsibility of
licensee.

That the agreement shall be a period of two years and may be renewed for a further period. Provided that
it shall not be terminated by mere efflux of time if the consumer is willing that the agreement is renewed.

That the agreement shall be terminated if the consumer on its part desires it so and gives to the MePDCL a
notice of not less than one month or on the part of the MePDCL, if the consumer has violated any of the
terms and conditions of the agreement.

Provided that on the part of the MePDCL notice shall be given to the consumer stating the reasons for the
proposed termination and giving him opportunity to state his case and his statement, if any duly considered
the agreement is terminated and the supply of Electricity cut off.

the terms and conditions of this agreement shall be effective from the date of commencement.
