This is to inform you that as inspected by the office of the undersigned on \_\_\_\_\_, it was found that you were utilizing your electricity connection for commercial purposes whereas, as per our office records, you had applied your electricity connection for Domestic purpose which is illegal and punishable as per section 126 of the Electricity Act 2003 & MSERC (Supply Code) Regulation, 2018.

In view of the above and to compensate for the loss of revenue to MePDCL, an Initial Compensation amounting to Rs. \_\_\_\_\_ only is hereby served against you for necessary within 7 days from the date of issue of this Notice and failure on your part to comply with these directions will leave the undersigned with no other options but to disconnect all your Electricity Supplies without further notice.

In case, you are aggrieved with the Initial Assessment Order (Bill), you may file an objection and make appropriate representation along with the documents to substantiate your claim within 7 (seven) days from the date of issue of this notice, else this notice shall be treated as Final Order and no further representation will be entertained thereafter.

If default in making payment within 15 days of the said Final Order, an additional amount of interest @16% p.a in addition to the assessed amount compounded every 6 (six) months will be charged against you.

Also, you are hereby directed to visit the Office of the Assistant Executive Engineer, UMSOHLANG UMSNING to change your category from the existing DLT to CLT within one month from the date of issue of this Order.

This is for your kind information and early necessary compliance.
