Sub: Provisional Compensation Bill.

Dear Consumer,

Your service connection bearing consumer no. 1222000287 and meter no. 11118978 was inspected on the 29.08.2025 and it was observed that

1. Your declared load is 2 KW DLT.

2. The maximum demand on your meter was found to be more than the declared load, that is, 5 KW DLT.

In view of the above, you have violated Section 126 and Section 10.1 of the Indian Electricity Act 2003 and Meghalaya Electricity Supply Code 2018 for which Compensation Bill No. 326 dated: 02<sup>nd</sup> September 2025 estimated on the value of excess use of load over the declared load amounting to Rs. 5568.00 (Rupees:Five thousand five hundred sixty eight) only, is served upon you.

You are requested to make payment within 15 days from the date of receipt of this bill at the Office of the B.C House Counter No. 1, MePDCL Shillong (timings 10:00am to 02:30pm). The power supply to your premises will be disconnected as per the provision of the Indian Electricity Act 2003 & Meghalaya Electricity Supply Code 2018, in the event of non-compliance.

In case you are aggrieved with the assessment of the compensation bill, you are to make appropriate representation along with documents to substantiate your claim within 7 days from the date of issue of this bill to the Assistant Executive Engineer, Investigation & Enforcement, MePDCL, Lumjingshai, Shillong.

If you are not satisfied with the final decision of the Assessing Officer, you may make an appeal to the Appellate Authority within 15 days. After the lapse of 15 days, no appeals will be entertained and the provisional compensation bill will be treated as final.

You are further requested to meet the Asst. Executive Engineer, Revenue Sub-Division II for enhancement of your load from 2 to 5 KW with fresh submission of test report after payment of the above compensation bill.
