AGREEMENT FOR SUPPLY OF ELECTRICITY
LOW TENTION



AN AGREEMENT made this is the 16th day of APRIL 2025
between SMTI SHANOSHA SILLIAN and his successors and assigns (hereinafter
referred to as the Consumer) of the One Part and The Meghalaya State Electricity Board an electricity
distribution licensee under the Electricity Act, 2003 and its successors and assigns (hereinafter referred to as
the Board) of the Other Part.

Note: The term 'consumer' includes an individual person (whether male or female), a body of
persons, a company, society, firm, association or organization.

WHEREAS, the consumer has applied to the Board for supply of electricity its premises and the
Board has agreed to give the supply under the terms and conditions hereinafter appearing.

NOW, THEREFORE, the agreement witnesses-

- (1) That the supply shall be given to the premises located at RAITONGBI RI-BHAI - DISTRICT
With the consumer as owner/occupier of ;
- (2) That the supply shall be for the purpose of 220 VOLT DLT SUPPLY the load
Whereof shall not exceed 2kw (1500) watt (s);
- (3) That the provision of the Electricity Act, 2003 and the Regulations, Code and Orders, including Tariff
Orders, as may be made from time to time by the Meghalaya State Electricity Regulatory Commission
Shall apply and bind the consumer and the Board alike;
- (4) That the consumer shall regularly and timely pay to the Board all charges and may be for the
Supply of electricity;
- (5) That the Agreement shall be for a period of two years and may be renewed for a further period :
Provided that supply shall not be terminated by mere efflux of time if the consumer is willing
That the agreement is renewed;
- (6) That the Agreement shall be terminated if the consumer on its part desires it so and gives to the Board a
prior notice of not less than one month or, on the Board, if the consumer has violated any of the terms
and conditions of the agreement:

Provided that on the part of the Board notice shall be given to the consumer stating the reasons for the proposed termination and giving him opportunity to state his case and his statement, if any, duly considered before the agreement is terminated and the supply of electricity cut off;

(7) That the terms and conditions of this Agreement shall be effective from the supply of electricity is commenced.
