Agreement for supply of electricity between

An agreement made on the 1st day of July, in 2014 between _____ and the consumer and supply distribution informed to us the consumer at the one part and the Maharashtra Power Distribution Corporation Limited as electricity distributor under the EA 2003 and its regulations and consumer informed to us in the Maharashtra Electricity Board (MEB) of the other part.

Whereas, the consumer has applied to the distribution utility for supply of electricity to his premises under the authorisation letter issued to you for supply under the terms and conditions herein after specified.

Whereas, the consumer has applied to the distribution utility for supply of electricity to his premises under the authorisation letter issued to you for supply under the terms and conditions herein after specified.

Now therefore, the agreement witness:-

- (1) That the supply shall be given to the premises located at Plot No. 101, Sector 1, Chinchwad with the consumer
as owner/occupier of;
- (2) That the supply shall be to the power of 0.55 _____
The time interval shall not exceed 2 hrs with
- (3) That the provisions of the EA 2003 and the regulations, code and orders including tariff orders, as may be made from time to time by the MBERC shall apply and bind the consumer and the distribution utility alike;
- (4) That the consumer shall regularly and timely pay to MEFDCL all charges as may be due for the supply of electricity;
- (5) That the agreement shall be a period of two years and may be renewed for a further period;
Provided that supply shall not be terminated by mere efflux of time if the consumer is willing that the agreement is renewed;
- (6) That the agreement shall be terminated if the consumer on its part desires it so and given to the MEFDCL a prior notice of not less than one month or, on the part of the MEFDCL, if the consumer has violated any of the terms and conditions of the agreement.

Provided that on the part of the MPPCL notice shall be given to the consumer stating the reasons for the proposed termination and giving him opportunity in that case and the statement, if any duty considered before the agreement is terminated and the supply of electricity cut off.

The terms and conditions of the agreement shall be effective from the date of supply of electricity is commenced.
