



WHEREAS, the consumer has applied to the Board for supply of electricity to its premises and the Board has  
agreed to give the supply under the terms and conditions hereinafter appearing

NOW, THEREFORE, the agreement witnesses

1) That the supply shall be given to the premises located at No. 12, Madan with the

2) That the provision of the Electricity Act, 2003 and the Regulations, Code and Orders, including Tariff Orders,  
which may be made from time to time by the Meghalaya State Electricity Regulatory Commission shall apply  
and bind the consumer and the Board alike.

3) That the consumer shall regularly and timely pay to the Board all charges and may be due for the supply of  
Electricity

4) That the Agreement shall be a period of two years and may be renewed for a further period

Provided that supply shall not be terminated by mere efflux of time if the consumer is willing that the  
contract be renewed.


5) That the Agreement shall be terminated if the consumer on its part desires it so and give to the Board a notice  
in writing not less than one month or, on the part of the Board, if the consumer has violated any of the terms and  
conditions of the Agreement

Provided that on the part of the Board notice shall be given to the consumer stating the reasons for the  
suspended termination and giving him opportunity to state his case and his statement, if any, duly considered before
