Sub:- Requesting for a change in power Load from 64 KVA to 48 KVA.

Respected Sir.

Firstly, This is regarding the power load for my Manufacturing plant Machines which was in Semi – Automatic previously and was supposed to be in 64 KVA, but now Currently, As the Machine has been replaced from semi -Automatic to Manual and after having due consultation with the Plant Manufacturer and with the Plant Engineer and as per advised now I would like to request for a change to decrease in the power load from 64 KVA to 48 KVA.

Secondly, As the security payment had been done as in accordance with the previous estimate for the power load of 64 KVA amounting to Rs 2,69,568 (Two lakhs sixty-nine thousand five hundred sixty-eight Rupees) as on dated 17th December 2024 and now the request for final power load will be 48 KVA. So, as there will have to be a refund for the same from your side. So I would request not to refund the amount instead keep it with you as in the future there will be an upgradation in my plant which can later be adjusted.

Therefore, kindly requesting you to look into the matter on a priority basis and do the needfull.
