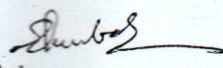

Dated Pdengshnong, the 13th. August, 1996.

Nga ka Bilir Kurbah, ka khun jong ka (L) Diri Kurbah kaba na Marbisu Sirdarship ryngkat bad ki khun jong nga ka Therbon Kurbah (Kurbah), u Kobarton Kurbah bad u Nebarton Kurbah, hapdengs ka jing koit jingkhiah bad tip briew bha, ngi die duh noh ia mar shiteng na ka jaka jong nga kaba kyrteng ka "Markhap Lailad Mawknan" kaba don ha ka shnong Pdengshnong, Marbisu Sirdarship, ha phi ka Dwisibon Kurbah kaba shong basah ka Mawknan-Pdengshnong (Marbisu) ha ka dor Rs.40,000/- (sawphew hajar tyngka), kat kum kine ki sawdong pud harum:-

Mihngi - Iakhapt bad ka khyndew ka Jrer Sun.

Sepngi - Iakhap bad ka Surok shnong (P.W.D.), Pdengshnong.

Shatoi - Iakhap bad ka Surok shnong (P.W.D.), Pdengshnong.
