2. Term

The term of this lease shall commence on 1st, December, 2024 and continue for a period of 11 (Eleven) Months unless otherwise terminated in accordance with the terms herein.

3. Rent and Payment Terms:-

- The Tenant shall pay a monthly rent of Rs.1,30,000/- (Rupees One Lakh Thirty thousand) only, payable in advance on or before the 10th day of
- Rent payments shall be made via cash or through other banking method to the Landlord's designated account.
- iii. A late payment fee of 1% shall apply for payments delayed beyond days.

4. Security Deposit:-

- The Tenant shall pay a refundable security deposit of three months i.e. Rs.3,90,000/- (Rupees Three lakh Ninety Thousand) only prior to
- The deposit shall be held by the Landlord as security for damages or unpaid dues and shall be refunded within 90 days after termination of the lease, subject to deductions.

5. Use of Premises:-

- The Tenant shall use the Premises solely for Vehicle Yard.
- The Tenant shall not sublease or assign the Premises without prior written consent of the Landlord.

6. Maintenance and Repairs:-

- The Landlord shall be responsible for structural repairs and maintenance.
- The Tenant shall be responsible for maintaining the interior of the Premises and minor repairs.

7. Termination:-

- i. Either party may terminate this Agreement by giving 30 days written
- The Landlord may terminate the lease immediately if the Tenant breaches any material terms of this Agreement.

8. Indemnity and Liability:-

The Tenant agrees to indemnify and hold harmless the Landlord from any claims, damages, or liabilities arising from the Tenant's use of the Premises.
