SOUTH: 100 FT: Big Village Drain.


An area of the Plot of land is measured about 10,000 Sq.ft more or less


The said plot of land was sold out for a sum of Rs. 450 /-
(FOUR HUNDRED FIFTY) only per square feet, the Seller have received and acknowledges the amount of money today the 19th OCTOBER, 2021.




I, Smti.Wansuklin Kharkongor (Purchaser) agreed to the rule and regulation. bounded by the DorbarShnong in respect to said plot of land.




