


The materials purchased by the consumer shall be inspected by Q.S & S wing, BESCOM, as per circular No: BESCOM/GM(QS&S)/DGM-3/BC-11/F-1425/2013-14/CYS-125/19.02.2014. Testing of all Self Execution Transformers irrespective of capacities at Transformer Testing Centers of BESCOM jurisdiction as per circular CGM(OP)DGM(OP-1)AGM(OP-3)/AE-1/BC-05/2020-21/CYS-164/29.03.2021 and before execution this certificate shall be given to the concerned A.E.E(E) of the Sub- Division. Take Necessary safety precautions while executing the work by Class-1 electrical contractor. If any Electrical / Mechanical accidents occurred without any safety precautions by the Electrical Contractor the BESCOM is not responsible. You should submit the relevant documents and details of Class-1 Electrical contractor to the concerned Sub division Officer & Section Officer before commencement of the work.


The materials like CT/PT are to be procured from approved BESCOM vendors. After completion of the work joint survey is to be taken by the Consumer/Section officer/Sub-division officer. Pre commission test has to be conducted by HT rating officials. After commissioning of the equipment, HT installation, the asset like new line and their equipment drawn up to metering cubicle is to be handed over to BESCOM as per regulation code 8.09 of conditions of supply of electricity. The applicant has to furnish a guarantee certificate,inspect of line materials and work for a period of one year from the date of service.


