- 1. The power supply will be arranged at 400 Volts.
- 2. The tariff applicable to your installation will be under LT-1 Tariff in force.
- 3. You have to enter into an agreement with the Company in the prescribed form as per Electrical supply regulations within 21 days failing which this intimation lapses.
- 4. Pay Security Deposit (2 MMD) of Rs.8,932/- X 01Nos (i.e. 11KW X 01 Nos) in cash or DD under Clause 1&3 of Regulation 31.
- 5. Meter should be purchased by consumer from retail outlet of BESCOM.
- 6. Submit the contractor's completion-cum-test report along with wiring diagram in duplicate.
- 7. Pay Rs.5,200/- towards Service Line Charges.
- (8.) Pay Rs.468/- x 2 No's towards 9 % each of CGST & SGST on Service Line Charges.
 - 9. Pay Rs.71,500/- towards IFC Charges.
- 10 Pay Rs.6,435 x 2 Nos towards 9 % of CGST + SGST each on IFC Charges.
- 11. Pay Rs. 150/- towards Supervision Charge.
- 12. Pay Rs.14/-x2 No's towards 9 % each of CGST & SGST on Supervision Charges.
- 13. You should provide circuit breaker as prescribed by the Corporate BESCOM Which must be errected with in one meter of the Company's meter Board or in such other position as shall be approved by the Corporation as per Regulation 409. No fuses shall be provided on the neutral conductor.
- 14. Power supply will be arranged to you only after errection of 25KVA Transformer.
- 15. **This is provisional intimation**, In case the above requirement are not complied WITH IN 90 DAYS from the date of this letter, sanction of power as well as registration will STAND CANCELLED and registration fee paid will stand forfeited.
