With reference to the above, as per the recommendation of SE, Ramanagara Circle, this office vide ref (6) had issued a power sanction for arranging HT power supply to an extent of 1950 KVA for Commercial purpose in favour of M/s RBD Shelters LLP, at Sy. No 41, 42, 43 & 44/3 Bhakthipura Attibele sub division, Chandapura division under self execution.

Earlier, the applicant has submitted a representation on 20-11-2024 vide ref (3) to this office to arrange power supply to an extent of 1000 KVA, out of sanctioned 1950 KVA due to non completion of civil works.

Considering the applicants request, this office vide ref(2) has accorded an approval to arrange power supply to an extent of 1000 KVA, out of sanctioned 1950 KVA for commercial purpose to the above commercial building, with some terms and conditions.
