- 4. The reduction of contract demand is final and it will not be revoked at later date.

The reduction of contract demand shall be with effect from the meter reading date following the expiry of, "two months" period from the date of registration of the application for reduction of contract demand / sanctioned load along with fresh agreement for reduced contract demand/ sanctioned load duly making payment of registration cum processing fee as prescribed under clause 30.01 of KERC.
- 6. The energy entitlement shall be re-fixed on Pro-rata basis (applicable during Power cut period).
- 7. Signature of the consumer shall be tallied with the signature in the original docket before effecting the reduction of load.
- 8. The Consumer has to pay arrears and audit short claims, if any, detected at a later date.
- 9. The Consumer has to give an undertaking that he will abide by the above Conditions / decision of the appellate authority in respect of pending appeal/ court cases, if any.
