

5. Pay TP Box charges **Rs.4,300/-**
6. Pay Meter Security Deposit of D11 **Rs. 2,808/-**
7. Pay **Supervision Charges** of **Rs.250/-** towards 5% of Estimate cost.
8. Please pay Material Inspection Charges of **Rs.5,000/-** (per work/time vide Corporate Orders: GM(TA&QC)/DGM/BRAZ/BC-35/11-12/CYS-26/Dt:27.06.2011.
9. The consumer should submit the original copies of invoice/bills in respect of materials purchased by the dealers.
10. There should not be marking of BESCOM P.O. No. on the poles in future.


