PREAMBLE:


1. The Commission in its Tariff Order-2023 dated 12-05-2023 has issued directives stating that "All the ESCOMs to take up a drive to obtain and link the RR numbers to Aadhaar Numbers, in respect of all the IP set installations of 10hp & below. In case the ESCOMs fail to link the RR numbers to Aadhaar numbers, the Government shall not release subsidy in respect of Such installation"
2. During MMR meeting held in Division and Circle office, it was directed to complete the linking of RR Numbers to Aadhaar Numbers, in respect of all IP set installations of 10hp & below within September-2025
3. As per the Directions were issued from MD, KPTCL through VC meeting held on 21-06-2024 i.e., name correction in case of spelling mistakes based on the data received from the field and as per the direction of MD BESCOM vide ref(5), to issue OM for approving the same to make necessary corrections in TRM.
