Guidelines were issued for the levy of supervision charges of 2.5% of estimate cost subject maximum of Rs.15 Lakhs and preparing single estimate for each stretch of continues road work vide this office letter number cited under reference-2.

In the said letter, it was requested to submit the accounts at end of financial year to the CGM(CA) section, BESCOM Corporate office and intern CGM(CA) section shall request the GoK to suitably adjust such notional loss in the subsidy being provided to BESCOM. In this regard CGM(CA) vide UO Note No.8452 dated: 29.01.2019 has stated that the subject issue is not dealt in CA section and regularly all the finalized accounts from different section at the end of financial year are being submitted to GM(A&RT) section.

Hence the following amendments is hereby issued.

GM(A&RT) shall consolidate all the intimations issued to National Highway Authorities of India from the respective sanctioning Authority (EEs/SEEs/CEEs) and shall take necessary action to collect the balance 7.5% of amount from the Government of Karnataka in the form of subsidy.

Remaining all other guidelines mentioned in the earlier letter remains unaltered.
