- g. Energy meter should be placed outside the premises at the height of 5ft from the ground level.
- h. Amount through DD should be paid in the name AEE RSD-01 BESCOM MOLAKALMURU .
- i. Intimation is valid up to 90 days from the date of issue.

In case the above requirements are not fulfilled within one month from the date of this communication, the sanction of power and registration will stand CANCELLED.
