1. The power supply will be arranged at 400 Volts.
2. The tariff applicable to your installation will be under LT-5 Tariff in force.
3. You have to enter into an agreement with the Company in the prescribed form as per Electrical supply regulations within 21 days failing which this intimation lapses.
4. Pay Rs. 26,565/- towards Security Deposit (2 MMD) of in cash or DD under Clause 1&3 of Regulation 31 (Deposit for 50 HP is Rs. 31,205/-, existing deposit is Rs. 4,640/-).
5. Pay Rs. 44,850/- towards Service line cost.
6. Pay Rs. 4,037/- x 2 No's towards 9 % each of CGST + SGST on Service Line Charges.
7. Pay Rs. 2,01,500/- towards IFC Charges.
8. Pay Rs. 18,135/- x 2 No's towards 9 % each of CGST + SGST on IFC Charges.
9. Pay Rs. 150/- towards Supervision Charges.
10. Pay Rs. 14/- x 2 No's towards 9 % each of CGST + SGST on Supervision Charges.
11. Meter should be purchased by consumer from BESCO.
12. Submit the contractor's completion-cum-test report along with wiring diagram in duplicate.
13. You should provide circuit breaker as prescribed by the Corporate BESCO Which must be erected with in one meter of the Company's meter Board or in such other position as shall be approved by the Corporation as per Regulation 409. No fuses shall be provided on the neutral conductor.
