With reference to your application, requesting for power sanction to an extent of 22 kW for above address, we are pleased to convey you sanction of additional power to an extent of 22 kW to existing 2 kW Total 24 kW subject to the following conditions.

- 1. The power supply will be arranged at 400 Volts.
- 2. The tariff applicable to your installation will be under LT-3 Tariff in force.
- 3. You have to enter into an agreement with the Company in the prescribed form as per Electrical supply regulations within 21 days failing which this intimation lapses.
- 4. Pay Security Deposit (2 MMD) of Rs. 35,586/-.

  (Deposit for 24 kW is Rs. 39,216/- Existing deposit is Rs. 3,630/- = Balance Rs. 35,586/-)
- 5. Pay Rs. 20,150/- towards Service line cost.
- 6. Pay Rs. 1,814/- x 2 Nos towards 9 % each of CGST + SGST on Service Line Charges.
