- 2) As per the request of seller, the consumer had gone (for Reduction load of contract demand) As per the request of school, from 10 kW to 04 kW as per BESCOM vide OM: 1952 dated 13/08/2025 and KERC order dated: 18/08/2021 and Hence this new SPPA has been executed.

For having agreed the aforesaid terms by SELLER and BESCOM Clause (a) Tariff of Power Purchase Agreement executed on date 30/08/2022 shall be replaced with the following Clause.

The BESCOM shall pay for the Net energy at 4.02 per kWh, as determined by the KERC order dated 18/08/2021 for the term of agreement.	a. The BESCOM shall pay for the Net energy at Rs. 3.61 per kWh of (90% of the tariff as determined by the KERC order dated 18/08/2021 for the term of agreement).

All other terms and conditions of the PPA dated: 30/08/2022.shall remain unaltered and enforceable and binding on the parties. This Supplemental Power Purchase Agreement (SPPA) shall form as part of the Power Purchase Agreement dated 30/08/2022
