Sub;	Arranging additional Power Supply of 200KVA to the existing HT installation bearing RR No. GRHT-20 having a connected load of 400KVA, total load 600KVA at Kaliinayakanahaili Village, Gowribidanur taluk. UNDER Self Execution - Reg.

BESCOM is pleased to communicate the power sanction to additional load of 200 KVA to the existing HT installation bearing RR no. GRHT-20, having a connected load of 400KVA total load to 600KVA in favor of M/s Bayer Cropscience Ltd At Kallinayakanahalli Village of Thondebhavi Section, Gowibidanur Sub-division, Chikkaballapura Division. "UNDER Self Execution".

The Power Sanction is subject to the following conditions:

- 1. All the work has to be executed as per sanctioned estimate under self-execution
- 2. The materials used shall conform to the relevant ISI specifications. The quality of the work such as shall be as per the standard drawings of the Licensee
- 3. The materials procured shall be in-accordance with the IE/BESCOM/KPTCL specifications and the materials shall be got inspected by AEE, Q,S&S, BESCOM Kolar Circle / Concerned Executive Engineer Ele, before erection in the field. The copies of the invoices / bills of the materials purchased shall be submitted as proof of purchased from the BESCOM approved vendors / dealers.
- 4. Joint inventory Report duly signed by the BESCOM Officers and agencies as prescribed vide Chief Controller of Accounts circular No:- AO/CYS-10/92-93/20-04-1992(page- 246 of compendium Vol-1) and Approval of the Electorate Inspectorate authorities (wherever applicable).
- 5. You have to pay the following amounts through DD, drawn in favor of AEE, BESCOM, Malur Sub-Division within 90 days from the date of this intimation and Electrical inspectorate charges to DEI, Govt. of Karnataka.
  - a. Rs. 2,710/- towards Supervision charges at 5% of estimate cost of Rs. 54,200/- (In future any difference you have to pay)
  - b. Rs. 500/- towards Load Enhancement Charges.
  - c. Rs. 4,12,000/- towards ISD under HT-2(a) tariff.

You have to execute the works as per approved estimate under self-execution through class-1 Licensec Electrical Contractor, under the supervision of BESCOM/KPTCL.

Guarantee shall be furnished for a period not less than Five year for the materials used for the works.
 Guarantee for period not less than one year for the quality of work carried out from the date of taking over the lines and equipment's by BESCOM.

- 7. Approval of the Electrical Inspectorate shall be obtained for the electrical equipment and lines before Commissioning as per the KERC norms
- 8. BESCOM is not responsible in whatsoever manner regarding any legal disputes that may arise at later stage.
- Any modification in the existing system shall be at the cost of developer with prior approval of the competent authority. Suitable safety clearance shall be maintained for the Electrical lines in accordance with the IE rules
- 10. NOC from concerned authority (PGCIL/KPTCL) shall be obtained whenever EHV lines pass in the premises.
- 11. You should clear the outstanding arrears of the installation inside the premises, if any
- 12. You should abide to the conditions of supply as per prevailing electricity act in force with subsequent amendments.
- 13. This sanction is subject to ratification and administrative approval from the competent authority.
- 14. After complying the above conditions the proposal will be sent to competent authority to accord administrative approval if necessary.
- 15. The payment certificate duly signed by the Concerned Subdivision, Assistant Executive Engineer(El), shall be sent to this office for issuing Administrative approval. Any delay in making payment, not fulfilling the above conditions within 90 days, the power sanction deemed to be cancelled as per the conditions stipulated in the KERC.

16. You have to pay any variation / difference of charges payable to BESCOM, if any in future.
