With reference to the above, as per the recommendation of this office and Ramanagara Circle Office, approval was accorded by Chief Engineer (E), BESCOM, O&M Bangalore Rural Area Zone vide Ref(2) & (3) for Enhancement of contract demand from 4400 KVA to 5500 KVA (Addition 1100 KVA) bearing RR No. AKLHT-293 under HT-2(a) tariff in favour of M/S Stride Pharma Science Ltd @ Sy No-36/7, Surajakkanahalli Village, Anekal Taluk, Anekal Sub-Division, as per the clause No. 34.01 KERC Conditions of Supply of Electricity of Distribution licensees in the State of Karnataka, subject to the following conditions:

- The Consumer has supplied the CTs and in presence of AEE, MT division, BRAZ, the MT Staff replaced the existing 11 KV, CTs of ratio 225 / 1A, 0.2S class of accuracy by new CTs of ratio 300 / 1A, 0.2s class of accuracy on 07-02-2025. The cost of the Sanctioned estimate is Rs. 1,51,02,919/- (Total rupees One crore Fifty one lakhs Two thousand & Nine Hundred & Nineteen only)
- Metering standards is as per BESCOM circular cited under ref -4.
- The Consumer has paid the following amounts in favour of AEE, BESCOM, Anekal sub division

4. The Additional contract demand is final and it will not be revoked at later date.
5. The Additional contract demand shall be **with effect from the Date of CT Replacement (MRT Date)** for Enhancement of contract demand / sanctioned load along with fresh agreement for Additional contract demand & to obey Section 32.04 & its amendments from time to time.
6. The energy entitlement shall be re-fixed on Pro-rata basis (applicable during Power cut period).
7. **Signature of the consumer shall be tallied with the signature in the original docket before effecting the Additional Contract Demand as per Norms.**
8. The Consumer has to pay arrears and audit short claims, if any, detected at a later date.
9. The Consumer has to give an undertaking that he will abide by the above Conditions / decision of the appellate authority in respect of pending appeal/ court cases, if any.
10. The installation shall be rated by M.T Staff before & after implementation of Additional load.
11. The Consumer shall abide by the rules/regulations, if any, left out and regulations issued at later dates.
12. **The capacity of any individual machinery / equipment installed / connected shall not be more than the approved CD.**
13. **If SRTPV Load is sanctioned to this Consumer, then the existing PPA has to be withdrawn with immediate effect and Supplementary PPA to be executed as per prevailing KERC / BESCOM Norms.**

All Other formalities shall be observed as per the prevailing KERC regulations.
