As per request of you are here by requested to pay the following charges to BESCOM within One month's (30 days) at the office of the Assistant Executive Engineer Ele., BESCOM Kanakapura Urban Sub Division for taking further needful action from this office subject to the following conditions.

- 1. The power supply will be arranged at 230/400 Volts
- 2. The Tariff applicable to your installation will be LT4(a)/ 10HP or the Tariff in force from time to time.
- 3. You have to enter into an agreement with the BESCOM in the prescribed Form.
- 4. Pay Charges towards

- 5. The supervision charges and other deposit amount paid by DD is to be drawn in the favor of Asst Executive Engineer (Ele) BESCOM, Kanakapura Rural Subdivision.
- 6. The above amounts shall be paid at RSD, BESCOM Kanakapura within 30 days from the date of this power sanction failing which the power sanction stands cancelled.
- 7. You are requested to avail power supply as per BESCOM rules and execute CR, wiring diagram, power supply agreement, and approval of Govt Electrical Inspectorate.
