## INTIMATION

With reference to your **online account ID: 1312103250275 dated 25.03.2025** requesting for arranging power supply to an extent of 100HP to power installation in favour of M/s Won Ventures Pvt. Ltd., Rep by Sri.Tejas J Badvram, kh no. 90/25 at Bheemenahalli village in M N Halli section of Bidadi Subdivision " Under Self execution basis".

### We write to convey sanction of power subject to the following conditions

- 1)The power supply will be arranged at 230/400 Volts.
- 2) The tariff applicable to your installation will be LT5b or the tariff in force from time to time.
- 3)You have to enter into an agreement with the BESCOM in the prescribed form.
- 4)You have to Pay 2 months minimum deposit for **40HP of Rs.27,900/-**(Rs. Twenty Seven Thousand Nine Hundred only).
- 5) Pay Supervision charges of **Rs. 14,711/-**@ 5% of the estimate cost(~~Rs. Fourteen Thousand Seven Hundred and Eleven only~~).
- 6) Pay Transformer testing charges of **Rs. 1,000/-**.(Rs. One Thousand Only).
- 7) Submit the contractors completion cum test report along with diagram in Duplicate.
- 8) You shall install LT metering panel approved by the BESCOM with suitable capacity MCCB and/or ELCB.

The above said amount to be paid in favor of Assistant Executive Engineer Ele, BESCOM, Bidadi sub division and to be deposited at the office and forward receipts copies and certificate of payment signed by Asst. Executive Engineer Ele, (Manager (F&C) or Sr. Assistant of the Sub-Division for taking further needful action from this office. In case the above requirements are not fulfilled within 90 days from the date of this communication, the sanction of power and registration will stand CANCELLED. The registration fee paid will be FOREFEITED.
