- Intimation is valid up to 30 days from the date of issue.

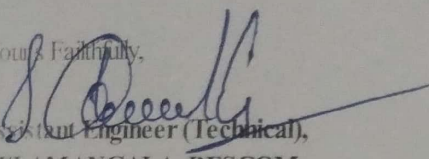


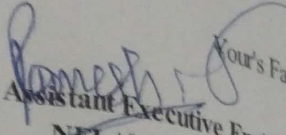
