The power is sanctioned subject to the following conditions:


1. You have to pay the below additional deposits at the Office of the AEE(E), Tiptur Sub Division.
  - a. ASD charge of Rs.17,000/-
  - b. 5% of Estimate Cost Charges of Rs.12,612/-
  - c. Supervision charges of Rs.150/-
  - d. MSD Charges Rs.2808/-
  - e. TP Box Rs.4300/-
2. The tariff applicable to your installation will be LT-4(a).
3. Power sanction is valid for 30 days from this date.
4. The applicant shall provide the required space in his premises & also provide at his own cost electric line, distribution transformer & associated equipment's.
5. The details of space provided by the applicant are a clear space of 3\*5 meters open to sky shall be provided within the applicants premises preferably at the main entrance for installing structure mounted distribution transformer BESCOM approved 25KVA (BEE-4 Star) & Switchgear.
6. You shall provide metal tamper proof box with separate meter and components at your own cost as per BESCOM specifications.
7. You shall provide three phase ETV meter at your own cost purchased at a BESCOM approved vendor.

Cost involved for arranging this power supply at your cost



- contractor as per the estimate approved by the Executive Engineer(Ele.,) (C, O&M) BESCOM. All the statutory approval required shall be obtained by you.
9. Arranging power supply to your installation will be after paying the above amount with CR wiring diagram and agreement.
  10. Red-yellow-Blue & Black color wires of size 2.5 Sq.mm multi core copper wire shall be used for meter wiring.
  11. Please furnish Govt. Licensed Electrical Contractor's completion report in duplicate with test results.
  12. Produce necessary license/permit/NOC etc., issued by the competent authority as required under statute.
  13. Guarantee shall be furnished for a period of not less than one year for the materials in the works as well as quality of works carried out from the date taking over the installation and equipment's by BESCOM.
  14. BESCOM reserves the right to cancel power supply & forfeiting of the deposits paid by you, if the documents submitted by you are duplicated/unauthorized.
  15. All the above Materials are to be purchased from Approved Vendor. Bills & Test reports of the same are to be produced at the time of servicing the installation.
  16. Approval from Electrical inspectorate shall be obtained before servicing the installation.
  17. The materials purchased by the consumer shall be inspected by EE/AEE, Q S & S Division, Chithradurga/Tumkur and necessary certificates should be produced before execution. The above work should be carried out under supervision of concerned A.E/J.E(O&M) Division, the Section.
  18. Your installation will be serviced as per prevailing BESCOM norms & KERC CoS.
