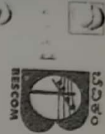

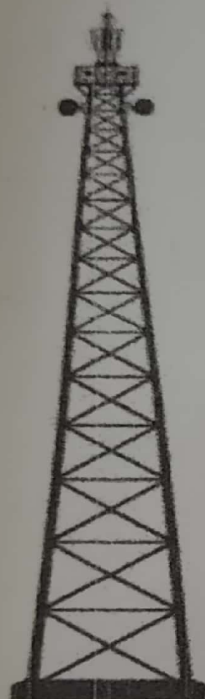


WIRING DIAGRAM OF THE.
