- f. You shall install LT metering panel approved by the BESCOM with suitable Capacity MCCB and/or ELCB.
- g. Energy meter should be placed outside the premises at the height of 5ft from the ground level.
- h. Amount through DD should be paid in the name AEE BESCOM CHANDAPURA .
- i. Intimation is valid up to from the date of issue.

You are requested to purchase the smart meter from the designated meter outlet by paying the necessary charges.
