- f. You shall install LT metering panel approved by the BESCOM with suitable Capacity MCCB and/or ELCB.
- g. Energy meter should be placed outside the premises at the height of 5ft from the ground level.
- h. Amount through DD should be paid in the name AEE BESCOM KYATSANDRA .
- i. Intimation is valid up to 30 days from the date of issue.

In case the above requirements are not fulfilled within one month from the date of this communication, the sanction of power and registration will stand CANCELLED. The registration fee paid will be FOREFEITED. You are requested to contact the Asst. Ex. Engineer Ele., KYATSANDRA Sub division, BESCOM for information and further needful.
