Sub: Electrification of Private Residential Layout to a requisite load of 318 KWs by Providing 1x250 KVA 5 Star rated Transformers in favour of Sri. D.Nagaraju S/o Doddamuniswamy &Sri.Shreyas R S/o Sri. Raghunath Sy No. 189 Alamabadi Village Malur Taluk, in O & M-Lakkur Section of Malur Sub Division Under Self-Execution.

Electrification of Private Residential Layout is developed in the area of 05 Acre 04 Guntas with 102 Nos of Residential Sites to a requisite load of 318 KWs by providing 1x250 KVA 5 Star rated Transformers in favour of Sri. D.Nagaraju S/o Doddamuniswamy &Sri.Shreyas R S/o Sri. Raghunath Sy No. 189 Alamabadi Village Malur Taluk, in O & M-Lakkur Section of Malur Sub Division Under Self-Executionis sanctioned and requested to fulfill the following conditions.

- 1. You have to pay the following amount at O&M Malur Sub-Division, BESCOM within period of 90 days from the date of this letter. Failing which the sanction stands cancelled.
 - Supervision Charges shall be collected 5% on Self-Execution CDS of Rs. 1, 09,099/- (Rupees One Lakhs Nine Thousand and Ninety Nine only) on Self-Execution portion of the Estimate Costing Rs. 21, 81,979/- (Rupees Twenty One Lakhs Eighty One Thousand Nine Hundred and Seventy Nine only).
- 2. You have to carry out the work involved for electrification of proposed residential Layout at your own cost under Self-Execution, through Class-I Electrical Contractor as per-the Estimate approved by the Asst. Executive Engineer (Ele), C, O&M Sub-Division, BESCOM, Malur.
- 3. You have to pay Rs. Rs. 1, 09,099/- (Rupees One Lakhs Nine Thousand and Ninety Nine only) towards 5% on Total Estimate Cost (Under Self-Execution) as onetime payment towards Maintenance of distribution work.
- 4. You have to pay Rs. 19,638/- (Rupees Nineteen Thousand Six Hundred and Thirty Eight only) towards GST @ 18% on onetime payment towards Maintenance of distribution work.

PROPOSALS:-

- 1. Work involves tapping of 11 kV F-5 Sampangere feeder feeding from 66/11KV Lakkur MUSS. It is proposed to provide 9 Mtr DP Structure with GOS at the tap ping point near the entrance of the gate. Work involves drawing of 11kV OH Covered Conductor to a distance of 0.08 Kms and LT 3 phase 5 wire secondary overhead AB Cable (route) line for a distance of 0.70 Kms.
- 2. This proposed 1x250 KVA 5 Star rated DTC comes on 11KV F-5 Sampangere feeder feeding from 66/11KV Lakkur MUSS with a peak load of 13 MWs and peak load of the feeder is 110 Amps.
- 3. 1x250 KVA 5 Star rated Transformers and its allied equipments will be installed by Distribution Licensee at the later date depending upon the load demand.
- 4. Required deposit and application shall be submitted to concerned Asst. Executive Engineer (Ele), C, O&M Sub-Division, BESCOM, Malur at the time of energisation of Layout.
- 5. The applicant has to maintain the vertical & horizontal clearance from building as per the Rule No.80 of IE Rule 1956, where high or extra high voltage overhead line passes above or adjacent to any building or part of the building.

The applicant has to maintain following corridor width, based on the voltage of EHV line if any EHT line pass through the Layout.

Materials used shall confirm to BESCOM specifications whenever necessary.

7. The entire Distribution system with the connected equipment shall be handed over to BESCOM after completion of the work.

- Guarantee shall be furnished for a period of not less than 1 year for the materials used in the work as well as the quality of the work carried out from the date of handing over of lines & equipments to BESCOM.
- 9. Proof of having purchased the materials used for executing the works for BESCOM vender approved firm will be verified whenever necessary.
- 10. After payment of Supervision Charges (Other Charges) which is given in the intimation work order will be issued by the Executive Engineer (Ele), C, O&M, BESCOM, K.G.F. Division.
- 11. Materials procured by the prospective consumer in respect of Self-Execution work shall confirm to BESCOM specification and shall be inspected by the jurisdictional Engineer, Electrical C, O&M or his authorized representative. The Executive Engineer (Ele)/ Asst. Executive Engineer(Ele), C, O&M Sub-Divisoin shall ensure that materials are purchased from approved venders. Proof of having purchased materials used for executing the works will be verified whenever necessary.
- 12. Other conditions specified in additional Class 3.2.1 of conditions of supply of electricity should be fulfilled.
- 13. Material Inspection fees of Rs.20, 000/- (Rupees Twenty Thousand only) shall be paid at Sub-Division office.
- 14. You have to pay Rs.3,600/- (Rupees Three Thousand Six Hundred only) towards GST @ 18% on Material Inspection Charges.
- 15. Separate Work Order will be given for drawing DTC's after payment of DCW charges as mentioned below.
