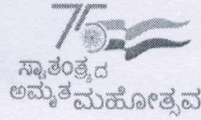

3. You have to give guarantee for the material used as well as the quality of the work executed at least for a period of one year from the date of service.
4. The purchased material is should be as per BESCOM Specification and shall confirm to ISI. The materials procured from approved vendor for this work shall be got inspected by QS&S section before they are used in the field. As per Circular No: BESCOM/GM(QS&S)/DGM-3/BC-11/F-1425/13-13/CYS-125/ Dated: 19.02.2014.
5. Pay **Supervision Charges** of **Rs.28,288/-** (Rs. Twenty eight thousand Two hundred & eighty eight Only) towards 5% of Estimate cost.
6. Please pay **Initial Security Deposit D2** of **Rs. 52,426/-** (Rs. Fifty two thousand four hundred & twenty six only)
7. Please pay **Material Inspection Charges** of **Rs.10,000/-**(Rs. Ten Thousand Only) per work/time vide Corporate Orders: GM(TA&QC)/DGM/BRAZ/BC-35/11-12/CYS-26/Dt:27.06.2011.
8. Please pay **Transformer Testing fee of Rs.1,000/-**(Rs. One Thousand Only) per transformer vide Corporate Orders: CGM(Op)/DGM(OP-1/AGM(OP-3/AE-1/BC-05/2020-21/CYS-164, Dated:29.03.2021.
9. The consumer should submit the copies of invoice/bills in respect of materials purchased by the dealers.
10. There should not be marking of BESCOM P.O. No. on the poles in future.


