With reference to the above, for arranging 05 KW's Temporary power supply sought by you is here by sanctioned for service to Temporary power supply subject to following condition.

- 1. Pay Rs.42,000/- towards ACC charges.
- 2. Pay Rs.30,932/- towards 5 % Supervision Charges on estimate cost.
- 3. Pay Rs.1.000/- towards on MRT transformer testing charges.
- 4. Pay Rs.10,000/- towards on material inspection charges.
- 5. You have to furnish necessary Self Execution agreement on Rs.200/- Stamp paper.
- 6. The work should be executed under the supervision of BESCOM authority observing the formalities and the materials are to be got approved by competent authority. You should stand guarantee for material and workmanship for a period of one year or the period for which the time is in service for T.P.S. whichever is less.
- 7. You should replace any damages or loss caused due to bad quality of material or workmanship at your cost.
- 8. The Materials to be procured by the agencies for execution of works on Total Turnkey, Partial Turnkey and Self execution works shall be invariable got inspected by TA&QC or Jurisdictional Executive Engineer (El.,) C,O&M as the case may be before commencement of Work.
- All the Major Materials shall be procured by the agencies only from the BESCOM approved vendors and other materials may be procured from authorized dealers of approved vendors of BESCOM.
- 10. The firms shall submit copies of the invoices / bills in respect of materials purchased by them for this work.
- 11. Tariff applicable to your installation will be LT-7.
- 12. Transformer installed under Self execution scheme has to be tested by the concerned MT Section as per circular cited under reference (4).
- 13. You have to produce the Completion Certificate from the local authorities before servicing the installation and should abide by all the regulations and conditions stated vide reference-4. You are requested to contact the Asst. Executive Engineer (Ele.) 0&M sub division, Devanahalli for further information.
