With reference to the above, as per the recommendations of this office vide ref-2, approval was accorded by SEE, RMG circle, BESCOM for reduction of contract demand of the existing HT installation from 700 KVA to 200 KVA (reduction 500 KVA) bearing RR No. CDPHT-164 under HT2A tariff in favour of M/S Supreme Fibre Glass, Plot No- 16, L-4, Attibele I/A, Attibele Hobli, Anekal Taluk, Attibele Sub-Divison, as per the clause No. 34.02 KERC Conditions of Supply of Electricity of Distribution licensees in the State of Karnataka, subject to the following conditions:

- The Consumer has supplied the CTs and in presence of AEE, MT division, BRAZ, the MT Staff replaced the existing 11 KV, CTs of ratio 35 / 1A, 0.2S class of accuracy by new CTs of ratio 10 /1A, 0.2s class of accuracy on 23-12-2024. The cost of the Sanctioned estimate is Rs. 46,015 /-(Total rupees Forty Six Thousand & Fifteen only)
- 2. Metering standards is as per BESCOM circular cited under ref -5.
- 3. The Consumer has paid the following amounts in favour of AEE, BESCOM, **Attibele** sub division

- 4. The reduction of contract demand is final and it will not be revoked at later date.
- 5. The reduction of contract demand shall be with effect from the meter reading date following the expiry of, "two months" period from the date of registration of the application for reduction of contract demand / sanctioned load along with fresh agreement for reduced contract demand/sanctioned load duly making payment of registration cum processing fee as prescribed under clause 30.01 of KERC.
- 6. The energy entitlement shall be re-fixed on Pro-rata basis (applicable during Power cut period.
- 7. Signature of the consumer shall be tallied with the signature in the original docket before effecting the reduction of load.

- 8. The Consumer has to pay arrears and audit short claims, if any, detected at a later date.
- 9. The Consumer has to give an undertaking that he will abide by the above Conditions / decision of the appellate authority in respect of pending appeal/ court cases, if any.
- 10. The installation shall be rated by M.T Staff before & after implementation of reduction of load.
- 11. The Consumer shall abide by the rules/regulations, if any, left out and regulations issued at later dates.
- 12. The capacity of any individual machinery / equipment installed / connected shall not be more than the approved reduced CD.
- 13. If SRTPV Load is sanctioned to this Consumer, then the existing PPA has to be withdrawn with immediate effect and Supplementary PPA to be executed as per prevailing KERC / BESCOM Norms.
- 14. The security deposit required shall be recalculated for the reduced contract demand on **Prorate** basis on average monthly bill of the preceding calendar year as per clause 34.04 and **balance** of **deposit shall be refunded to the consumer duly observing the KERC/ BESCOM norms.**

All Other formalities shall be observed as per the prevailing KERC regulations.
