With reference to the above, as per the request of the consumer ref-1 and as per the recommendations of the Assistant Executive Education Ele., Jigani Sub Division vide ref-2, approval is here by accorded for Temporary Reduction of contract demand of the existing HT installation from 350 KVA to 25 KVA by reducing 325 KVA, bearing RR.No.AKLHT-771, under HT2A tariff in favour of M/S Classic Welding Products Pvt Ltd, No.42-P2 & 41-P, Jigani Bommasandra Link Road I/A, Jigani Link Road O&M of Jigani Sub Dvision, Anekal Taluk as per clause No. 34.02 of KERC condition of supply of Electricity of Distribution licensees in the State of Karnataka, subject to the following conditions.

- 1. The Temporary reduction of load is for a period of maximum 6 months only from the date of OM.
- Any usage of demand over and above the reduced contract demand during the period is liable to penalized and as per prevailing KERC regulations / norms.
- 3. The Energy entitlement shall be re-fixed on pro-rata basis (applicable during power cut period).
- 4. The installation shall be rated by M T staff for ascertaining healthy of the metering equipment's.
- 5. The connected load of any single machine should not exceed the reduced contract demand.

6. Signature of the consumer shall be tallied with the signature in the original docket before effecting the Temporary reduction of load.

7. The consumer has to pay arrears and audit short claims, if any

detected at a later date.

8. The consumer has to give an undertaking that he will abide by the above Conditions / decision of the appellate authority in respect of pending appeal / court cases if any.

9. The installation shall be rated by MT staff before & after

implementation of temporary reduction of load.

10. The consumer shall abide by the rules / regulations, if any left out and KERC regulations issued at later dates.

All other formalities shall be observed as per the prevailing KERC regulations and other terms & condition of the sanction stands unaltered.
