We write to convey sanction of power subject to the following conditions

- 1)The power supply will be arranged at 230/400 Volts.

- 6)Pay TP box of Rs. 3,644/-(Rs. Three Thousand Six Hundred and Fourty Four Only).
- 7) Pay Supervision charges of Rs. 11,270/- @ 5% of the estimate cost(Rs. Eleven Thousand Two Hundred and Seventy Only).
- 8) Pay Transformer testing charges of Rs. 1,000/-(Rs. One Thousand Only).
- 9) Submit the contractors completion cum test report along with diagram in Duplicate.
- 10) You shall install LT metering panel approved by the BESCOM with suitable capacity MCCB and/or ELCB.

The above said amount to be paid in favor of Assistant Executive Engineer Ele, BESCOM, Bidadi sub division and to be deposited at the office and forward receipts copies and certificate of payment signed by Asst. Executive Engineer Ele, (Manager (F&C) or Sr. Assistant of the Sub-Division for taking further needful action from this office.
