Veerasandra Sub division vide ref-2, approval is hereby accorded Reduction of contract demand of the existing HT installation from 200 KVA to 130 KVA (reduction 70 KVA) bearing RR No. VSHT75 under HT-2(ii) tariff in favour of M/S Tirumala Service station at plot no.233A BIA in Ananthanagara O&M unit Anekal Taluk Veerasandra Sub-division, as per the clause No. 34.02 KERC Conditions of Supply of Electricity of Distribution licensees in the State of Karnataka, subject to the following conditions:

- 1. The Consumer has to supply the CTs and in presence of AEE, MT division, BRAZ, the MT Staff replaced the existing 11 KV, CTs of ratio 10/1A, 0.2S class of accuracy by new CTs of ratio 7.5/1A, 0.2s class of accuracy, The cost of the Sanctioned estimate is Rs.46,793/-(Total Forty Six Thousand Seven Hundared Ninety Three rupees only)
- 2. Metering standards is as per BESCOM circular cited under ref -5.
- 3. The Consumer has paid the following amounts in favour of AEE, BESCOM, Veerasandra sub division

- 4. The reduction of contract demand is final and it will not be revoked at later date.
- 5. The reduction of contract demand shall be with effect from the meter reading date following the expiry of, "two months" period from the date of registration of the application for reduction of contract demand / sanctioned load along with fresh agreement for reduced contract demand/ sanctioned load duly making payment of registration cum processing fee as prescribed under clause 30.01 of KERC.
- 6. The energy entitlement shall be re-fixed on Pro-rata basis (applicable during Power cut period.
- 7. Signature of the consumer shall be tallied with the signature in the original docket before effecting the reduction of load.
- 8. The Consumer has to pay arrears and audit short claims, if any, detected at a later date.
